## NOTIFICATION OF ELECTION OF IAOMR ADMINISTRATIVE OFFICE BEARERS FOR THE YEAR 2024-25

### ELECTION NOTIFICATION

The elections for the Administrative Office bearers of the Indian Academy of Oral Medicine & Radiology (IAOMR) for the year 2024-25 will be held during the forthcoming **35th Annual General Body Meeting** of the Indian Academy of Oral Medicine & Radiology (IAOMR) on **Saturday 23rd November 2024** at the **Indiana Convention Center, Mangalore**.

Elections will be held for the following posts for the Administrative Office of IAOMR for the year 2024-25:

- 1. President-Elect (2024-25): 1 Post**
- 2. Vice-Presidents (2024-25): 5 Posts (at least two should be women)**
- 3. Executive Committee Members (2024-25): 10 Posts (three post reserved for women)**

#### Eligibility criteria for candidates:

##### 1. President-Elect:

- a) Must be a life member of IAOMR
- b) Must have at least 10 years of good standing as a life member
- c) Must have served in office for a minimum of 3 terms

##### 2. Vice-President:

- a) Must be a life member of IAOMR
- b) Must have at least 10 years of good standing as a life member
- c) Must have served in office for a minimum of 3 terms

##### 3. EC Member:

- a) Must be a life member of IAOMR
- b) Must have at least 5 years of good standing as a life member

Elections for all positions except President will be held during the AGBM as per the election procedure. Once elected, office bearers must attend at least 3 EC meetings or 50% of EC meetings for that term, whichever is lesser.

#### KINDLY NOTE THE FOLLOWING:

- Any IAOMR life member in good standing who wishes to contest for office must file a nomination (in the prescribed proforma), proposed and seconded by two IAOMR members, with the candidate's consent.

- The nomination form must include a non-refundable deposit of INR 5000/- (online payment only), along with photocopies of the MDS degree certificate (as per the constitutional amendments adopted in 2017), PAN card, government-issued address proof, and 3 recent passport-size photographs.

A person can contest for only one post. Incomplete nomination forms or those received after the specified date, **08-11-2024** (15 days prior to AGBM), will be rejected. Non-receipt of forms at the Head Office for any reason will not be considered for inclusion in the election.

Candidates may withdraw their candidature until **13-11-2024** (10 days prior to AGBM). The INR 5000/- deposit will be refunded to candidates who withdraw within the stipulated time.

If more than one candidate files a nomination for a post, an election will be held. If no nomination is received for a post, floor nominations will be made at the AGBM, with the candidate's name duly proposed and seconded. If more than one candidate contests a post through floor nomination, an election will be conducted.

If the number of Vice-President posts and the number of nominations are equal, voting will still take place to determine the order of the Vice-Presidents (e.g., 1st, 2nd, etc.).

No office bearer can hold the same post for two consecutive terms.

The names of other candidates standing for election will be revealed at the AGBM only. Candidates are requested to avoid negative campaigning, mudslinging, or making allegations, as these actions will demean the dignity of the academy.

Sealed envelopes containing the filled nomination form, photocopies of the MDS degree, PAN card, government-issued address proof, and 3 passport-size photographs should be superscripted as "IAOMR Election – 2024" and sent to:



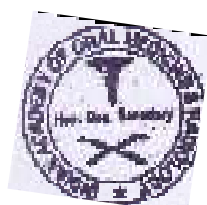
