## ELECTION NOTIFICATION

In the forthcoming 30<sup>th</sup> Annual General Body Meeting of Indian Academy of Oral Medicine & Radiology (IAOMR), to be held on the 24<sup>TH</sup> November 2018, Elections for the following posts for the Administrative Office of IAOMR (henceforth referred to as the Academy) will be a part of the Agenda.

Nominations from eligible members are invited for the following posts to be elected for the year 2019:

| 3. Head Office Joint Secretary(2019-20): | 1 Post(only female)                                 |
| 4. Executive Committee Member(2019):     | 10 posts, of which at least three should be Ladies. |

### KINDLY NOTE THE FOLLOWING:

- Please note This year Elections will be held by using Digital voting machine during AGM, So IAOMR ID Card and LM number is must to cast your valuable vote. If You don't have IAOMR ID card you may have to produce original photo ID card issued by government authorities, like Aadhar, Voters card, Passport, Driving license.
- The Election will be held only for above mentioned posts as per constitution.

- Any IAOMR life member with good standing who wishes to contest for the office shall file nomination (in the prescribed proforma), proposed & duly seconded by (two) members with the consent of the candidate.
- The nomination form should be sent along with non-refundable deposit amount of INR 5000/- (By demand draft or online transfer to "INDIAN ACADEMY OF ORAL MEDICINE AND RADIOLOGY" VIJAYA BANK, account number: 401101011006397, IFSC CODE-VIJB0001422, Branch-RAJARAJESWARINAGAR, BENGALURU, photocopy of MDS degree certificate & acknowledgement of online transfer, if you are an Past office bearer of the Academy you may have to enclose certificate issued by the office stating you are an office bearer. (as per the new constitutional amendments adopted in 2017).
- One person can contest for only one post.
- Incomplete nomination forms or those received after the specified date i.e., 09-11-2018 (15 days prior to AGBM) will be rejected. Non-receipt of forms at the Head Office due to any reasons will not be considered for inclusion in the election.
- Candidates can withdraw their candidature till 14-11-2018, i.e., 10 days prior to the AGBM. The deposit amount of INR 5000/- will be refunded to those candidates withdrawing their nomination within the stipulated period.

- For the post of President-Elect and Vice-President, the member should have 10 years of good standing experience as life member of the academy, out of which he/she should have served the office for 3 terms.
- For the post of Head Office Joint Secretary, the member should have 5 years of good standing experience as life member of the academy, out of which he/she should have served the office for 2 terms.
- For the post of EC member, the member should have 5 years of good standing experience as life member of the academy.
- Please note that the experience as associate life member shall not be included in the good standing experience as life member of the academy.
- A person in good standing is regarded as having complied with all their explicit obligations including payment of dues, if any, to the academy, while not being subject to any form of sanction, suspension or disciplinary censure and having attended at least 2 EC meetings or 50% of the EC meetings (whichever is less) conducted each year, if the person has served the academy as an administrative office bearer.
- If more than one candidate has filed nomination to an office, election by secret ballot shall be conducted.
- If no nomination has been received for a post, election will be held for that post by floor nomination in the AGBM, the name of the candidate duly proposed and seconded. If there is more than one person contesting for one post in the floor nomination, election shall be conducted.
- No office bearer can continue to hold the same post for two successive terms.
- Names of other contestants standing for the elections will be revealed at the AGBM only. Candidates may please avoid negative campaigning / mudslinging / allegations, as these will demean the dignity of the academy.
- Sealed envelopes containing the nomination form, demand draft, acknowledgment of online transfer, copy of PAN card, 3 copies of passport size photographs and photo copy of MDS degree certificate along with a covering letter should be superscripted as "IAOMR Election-2018" and send or email to:
