## NOTIFICATION OF ELECTION OF IAOMR ADMINISTRATIVE OFFICE BEARERS FOR THE YEAR 2025-26

### ELECTION NOTIFICATION

The elections for the Administrative Office bearers of the Indian Academy of Oral Medicine & Radiology (IAOMR) for the year 2025-26 will be held during the forthcoming **36<sup>TH</sup> Annual General Body Meeting** of the Indian Academy of Oral Medicine & Radiology (IAOMR) on **Saturday 22<sup>nd</sup> November 2025** at the **D Y Patil Dental College Navi Mumbai**.

**Elections will be held for the following posts for the Administrative Office of IAOMR for the year 2025-26:**

President-Elect (2026):	01 Post
Vice-Presidents (2026):	05 Posts (at least two should be women) one year term. (2026)
Hon Gen Secretary (2026-27)	01 post for 2 year term (2026-27)
Head Office Treasurer	01 Post – 2 year term (2026-27)
Joint Secretary (2026-27)-	02 post for 2 year term ( one should be women) (2026-27)
Editor – in –chief (2026-27)	01 post 2 Year term (2026-27)
Registered Office Secretary –	01 Post – 2 year term (2026-27)
Registered Office Jt Secretary –	01 Post – 2 year term (2026-27)
Registered Office Treasurer –	01 Post – 2 year term(2026-27)
Executive Committee Members (2026):	15 Posts (at least 5 should be women) One year term. (2026)

**Eligibility criteria for candidates: Kindly down load the newly amended constitution 2024-25  
from the website, and later fill the form.**

Elections for all positions except President will be held during the AGBM as per the election procedure. Once elected, office bearers must attend at least 3 EC meetings or 50% of EC meetings for that term, whichever is lesser.

### KINDLY NOTE THE FOLLOWING:

Any IAOMR life member in good standing who wishes to contest for office must file a nomination (in the prescribed proforma), proposed and seconded by two IAOMR members, with the candidate's consent.

The nomination form must include a non-refundable deposit of INR 5000/- (online payment only), along with photocopies of the MDS degree certificate (as per the constitutional amendments adopted in 2024-25), PAN card, government-issued address proof, and 3 recent passport-size photographs.

The IAOMR Life member can contest for only one post. Incomplete nomination forms or those received after the specified date, **07-11-2025** will be rejected. Non-receipt of forms at the Head Office for any reason will not be considered for inclusion in the election.

**Candidates may withdraw their candidature by 12-11-2025 before 5.00 pm (10 days prior to AGBM). The INR 5000/- deposit will be refunded to candidates who withdraw within the stipulated time.**

If more than one candidate files a nomination for a post, an election will be held. If no nomination is received for a post, floor nominations will be made at the AGBM, with the candidate's name duly proposed and seconded. Payment of Rs 5000/- should be done for floor Nomination. If more than one candidate contests a post through floor nomination, an election will be conducted.

If the number of Vice-President Posts and the number of nominations are equal, voting will still take place to determine the order of the Vice-Presidents (e.g., 1st, 2nd, etc.).

No office bearer can hold the same post for two consecutive terms.

**The names of other candidates contesting for election will be revealed in the website of IAOMR after the date of withdrawal and EC meeting specifically called to scrutinize the nomination.** Candidates are requested to avoid negative campaigning, mudslinging, or making allegations, as these actions will demean the dignity of the academy.

**Sealed envelopes containing the filled nomination form, photocopies of the MDS degree, PAN card, government-issued address proof, and 3 passport-size photographs should be superscripted as "IAOMR Election – 2025-26" and sent to the following address on or before 07-11-2025.**
