President Dr. Neeta Misra Read the Agenda

The conduct of National level events within the Country was changed to can be, considered as Triple O symposium and National PG convention can be conducted abroad. But the National conference has to be conducted within INDIA.

The Number of EC post was increased to 15 with 05 for Women and as described in the Amendment's. The post of Past Hon secretary for the period of one year was created to have smooth functioning of the Office so that the programmes will continue as the schedule with

guidance to the newly elected Hon secretary. Rest of the amendments were proposed and passed by the members.

Dr. Manisha M. Khorate, Editor in Chief of JIAOMR, gave an update on the journal issues and the IAOMR Times for the year 2024. She mentioned that the journal is now concentrating on quality of research article than the quantity as the number of articles to be published is being achieved. In the last 3 issues of volume 36, a total of 49 original articles, 4 Systematic reviews, 12 case reports and 6 Short Communication have been published, with additional 28 manuscripts in various categories in production for the 4th issue, which will be released in Dec 2024. The APC charges are maintained at Rs 4720/- for members and Rs 11800/- for non-members.
